I fully accept and assume all such risks and all responsibility for losses, costs, damages, or injuries and I incur as a result in my minor's participation in the activity that I hereby release and forever discharge, and covenant not to sue or hold liable the Hurricanes Wrestling Club, the Mebane Arts & Community Center, the Mebane Recreation and Parks Department, any property owners where this event may take place, any sponsors and suppliers of the tournament, any officers, directors, coaches or chaperones of participating teams, tournament officials, volunteers, participants, and participant's parents.
